GENERAL SHOW REGULATIONS PROHIBITED ITEMS AND ACTIONS NEW YORK GUN SHOWS Carrying of firearms in holsters, belt or pocket. No loaded firearms in Show. All exhibitors agree to abide by all Federal, State and Local firearms and tax laws. Obey modern handgun ammunition sales regulations. Collector boxed ammo All exhibitors agree to conduct business in an ethical manner and are expected to should be sealed. Loose collector ammo to be displayed as to prevent pilferage have their displays uncovered and staffed during entire public viewing hours of 9am–5pm Sat. and 9am–3pm Sun. Single day rentals may be available at regular and accessibility. No operative Class III weapons. No Black Powder, explosive devices, hand grenades, etc. All displays must have full table covers. Rental consists of tabletop and directly No Racial or Ethnic propaganda, explicit sexual content, current political pamphlets below. Do not block aisles. All firearms must be covered before entering and and material, nor advertising conflicting with NEACA Shows without prior approval! leaving the building. Display of loose, matching ammunition to firearm is expressly forbidden. No loaded guns are allowed in show. All modern gun actions must be No jewelry, cameras, tools, watches, books, minerals, stamps, coins, etc. that do not have a significant historical value and/or relationship to the shooting sport or tied to prevent firing. NY State requires buyer to have gun lock. outdoor sports or to militaria collecting. No flea market material or bulk nonrelated items. Transfers of modern (post 1898) handgurs to the public will not be allowed at show, at place of business only. Obey all NICS Federal and State firearm laws. NEACA Shows are primarily designed for the Gun and Militaria Collector, Re-Tables must be ordered on an individual exhibitor basis. Table holders may receive 2 badges, one for exhibitor and one for bona fide employee or immediate family member. Children under 16 are not counted against exhibitor badges, "state enactor or Historian and as such we will discourage, though not prohibit, new firearms of current manufacture. Exhibitors of collector items will take preference over those with new, non-collectible items. NEACA Executive Officers feel legitimate Firearms Shops are where the hunter or shooter should find new guns ages." Replacement badges are \$10.00, do not loose or forget yours. Tables are not transferable. Should you vacate a table it will revert back to NEACA. and accessories and also where they should find better service for their needs. for resale. Tables not occupied by 9:00 AM Show Time, may be resold by NEACA. NEACA reserves the right to refuse table rental space. No two-way radios, electronic devices, use of birdcalls, and use of AM/FM radios No concealed firearms are permitted nor worn exposed or in belt on show premises. All exhibitors are solely responsible for the safety of their displays and security of or TV's that may irritate neighboring exhibitors or interfere with security without their exhibits and guests. NEACA will provide 24 hour armed security for the building. A Master at Arms is appointed at each show to enforce NEACA and prior NEACA approval. Do not use racks or shelves with solid backs that extend over 24" from the tabletop. show regulations. Use of our porters is available but at exhibitor expense and Open gun racks are permitted if they do not block the view of other exhibitors. Wall tables, if requested and available, will not be subject to this prohibition. sole risk Table rental reservation requests must be signed and completely filled in and Do not use Flags or rags for table covers together with rental fees submitted to NEACA, Inc or its officers. Confirmation No smoking is allowed in building. Alcoholic beverages are not allowed in exhibit hall except at previews or when expressly stated. and show badges will be mailed as soon as possible. For upcoming shows, a deposit of one table will be accepted for reservations, provided the full balance is If any other item or items are deemed objectionable or inappropriate for display, the NEACA Master at Arms will ask for its removal and may enforce these general paid 14 days prior to show date. Refunds will be made if received by written request 14 days prior to show date.
